Peoples Bank of Canada (PBC): Website Terms & Conditions of Use

PLEASE CAREFULLY READ THIS AGREEMENT, WHICH GOVERNS YOUR USE OF PEOPLES BANK OF CANADA'S (PBC'S) WEBSITE AND THE CONTENT, INFORMATION AND SERVICES PROVIDED ON OR THROUGH THE WEBSITE AND BY EMAIL. IT EXEMPTS PBC AND OTHER PERSONS FROM LIABILITY OR LIMITS THEIR LIABILITY, AND, CONTAINS OTHER IMPORTANT PROVISIONS THAT YOU SHOULD READ. EACH TIME YOU USE THE WEBSITE, THIS AGREEMENT AS IT THEN READS WILL GOVERN YOUR USE. ACCORDINGLY, WHEN YOU USE THE WEBSITE YOU SHOULD CHECK THE DATE OF THIS AGREEMENT (WHICH APPEARS AT THE TOP OF THIS AGREEMENT). IF YOU DO NOT AGREE WITH THIS AGREEMENT, YOU MAY NOT USE THE WEBSITE. 1. Your Acceptance of this Agreement

This Agreement constitutes an agreement between you and all persons you represent (and for purposes of this Agreement, "person" includes natural persons and any type of incorporated or unincorporated entity or organization) and PBC, and governs your access to and use of the PBC website and the content, information and services provided on or through the website and by e-mail, including all on-line tools (including applications and calculators) and e-mail alerts (the "Website"). This Agreement also provides benefits and protections to PBC's affiliates, service providers, suppliers of services to PBC or to you through PBC Online Banking or otherwise, and sub-contractors, and other affiliates, service providers, suppliers of services, or sub-contractors with whom PBC may do business or who provide services to you from time to time through the Website (collectively the "Affiliates and Providers"). Each time you use the Website you signify your acceptance and agreement, and the acceptance and agreement of all persons you represent, without limitation or qualification, to be bound by this Agreement as it then reads, and you represent and warrant that you have the legal authority to agree to and accept this Agreement on behalf of yourself and all persons you represent. 2. Changes to these Terms and Conditions

PBC may, in its discretion, change, supplement or amend this Agreement from time to time, for any reason, and without any prior notice or liability to you or any other person, by posting a revised agreement on the Website. Each time you use the Website, you should check the date of

The Website allows users to complete and submit applications for accounts and other products and services ("Online Applications"), and to request information regarding PBC's products and services ("Online Requests"). Online Applications and Online Requests may only be made using appropriate application forms available through the Website, and not through e-mail.

4. Seek Personalized Advice

Except for Online Banking Services, Online Applications and Online Requests, the Website is for information or general illustrative purposes only. The Website is not guaranteed to be accurate, complete, or timely. The Website is not intended to be a comprehensive, detailed or personalised source of information about personal or business banking, finance, investment, insurance or financial planning issues, products or services. We encourage you to seek personalized advice from qualified professionals before making any banking, finance, investment, insurance or financial planning decisions based upon any information provided on or though the Website. All PBC accounts, products and services are subject to the terms of the applicable agreements governing their use.

5. Website Communications

All information you provide through the Website, including your legal name, residential address, e-mail address, and information relating to On-line Banking Services, Online Applications and Online Requests, must be true, accurate, current and complete. PBC will rely on the information you provide. You will be solely responsible and liable for any and all loss, damage, and additional costs that you, PBC or any other person may incur as a result of your submission of any false, incorrect or incomplete information. You authorize PBC to: (a) accept communications PBC

receives from you by means of the Website as if those communications had been given directly by you in writing and signed by you; (b) disclose your communications to our service providers employees and representatives in accordance with our Privacy Policy by means of the Website, e-mail or other communications; and (c) respond to your communications by means of Internet communications, e-mail or other communications. Communications you send to PBC by means of the Website and e-mail are not effective unless and until they are processed by the responsible PBC representative. PBC may refuse to process any communications sent to PBC by means of the Website or e-mail, or may reverse the processing of any communications sent to PBC by means of the Website or e-mail, at any time in PBC's discretion, and without any notice or liability to you or any other person, including without limitation if: (a) PBC cannot process the communications; (b) the communications violate any provision of this Agreement or any other agreement that you or any other person may have with PBC; (c) PBC considers that the communications may conflict with any other instructions or agreements with you or any person you represent; or (d) there is an operational failure or malfunction in connection with the transmission of the communications.

A copy of any electronic communication will be admissible in any legal, administrative or other proceedings in the same manner as an original document in writing. You agree to waive any right to object to the introduction of any copy of electronic communications in evidence.

6. Currency and Interest Rates

All references in the Website to currency are to the lawful currency of Canada, unless expressly stated to be otherwise. Interest rates indicated on the Website are subject to change without notice.

7. Privacy and Security

PBC is committed to ensuring that personal information you have provided to us is accurate, confidential, and secure. Our privacy policies and practices have been designed to comply with the Personal Information Protection and Electronic Documents Act (Canada) or corresponding provincial privacy acts, as applicable (collectively, "Privacy Laws"). Our Privacy Policy is available on our Website, or by calling us in Vancouver at 778-309-4860, toll free at 833-309-4860, or emailing us at deposits@peoplesbank.ca. You can also obtain a copy from any of our office locations. By applying to open an account with, or purchase a product from, PBC, you consent to the collection use, and disclosure of your personal information in accordance with our Privacy Policy. You also agree that in order to establish your identification and to protect both you and PBC from fraud, we may collect and use your personal information that has been obtained from the financial institution holding your external account, credit bureaus, credit reporting agencies, and credit insurers. We maintain secondary disaster data back-up on computer systems located outside of Canada. Personal Information collected by us pursuant to our Privacy Policy may be stored,

whether as part of our secondary disaster data back-up or otherwise, on out-of-country computer systems, and therefore may be subject to disclosure pursuant to the laws of the jurisdictions where such personal information data is stored. PBC will disclose personal information as required by law.

8. Warranties and Limitation of Liability

This Website (including all information and documents contained on the Website) is provided "as is" and "as available" without any representation, warranty or condition of any kind (whether express, implied or statutory), and including without limitation any representation, warranty or condition or title, non-infringement, merchantability, fitness for a particular purpose, performance, durability, availability, timeliness, accuracy or completeness, all of which are hereby disclaimed by PBC to the fullest extent permitted by law. There will not be any representation, warranty or condition created by a course of dealing, course of performance or trade usage. Your use of this Website is at your own risk. Although the Website may be linked to other sites, PBC is not, directly or indirectly, implying any approval, association, sponsorship, endorsement or affiliation with the linked site, unless specifically stated therein. By entering the Website you acknowledge and agree that PBC has not reviewed all sites linked to the Website and is not responsible for the content of any off-site pages or any other site linked to the Website. Your linking to any other off-site pages or other sites is at your own discretion and risk. You should be aware that off-site pages or other sites might be available only in English or in other languages. Any proceeding commenced by you or on your behalf regarding a Dispute must be commenced in a court of competent jurisdiction in Vancouver, British Columbia within six months after the Dispute arises, after which time any and all such proceedings regarding the Dispute are barred.

15. Language
